Indian Equities:

Market may open lower

*Trading of Nifty 50 index futures on the Singapore stock exchange indicates that the Nifty could fall 46 points at the opening bell.

*Overseas, Asian stocks were mostly higher on Wednesday as investors in Asia-Pacific reacted to the release of China's latest benchmark lending rate. The moves in Chinese stocks came as the one-year prime rate (LPR) and five-year LPR in China were both left unchanged at 3.85% and 4.65%, respectively.

Corporate News

*Tata Communications: The company reported consolidated profit at Rs 309.4 crore in Q3FY21 against Rs 384.8 crore in Q2FY21, revenue fell to Rs 4,222.8 crore from Rs 4,401.1 crore QoQ.

*Bombay Dyeing & Manufacturing : Baymanco Investments acquired 54.70 lakh equity shares in the company at Rs 78.40 per share on the BSE. However, Heera Holdings and Leasing sold 17.52 lakh shares, Sahara Investments 18.38 lakh shares and Nidhivan Investments & Trading Company 18.80 lakh shares at Rs 78.40 per share.

*Network18 Media & Investments : The company reported consolidated profit at Rs 333.38 crore in Q3FY21 against Rs 68.01 crore in Q2FY21, revenue rose to Rs 1,422.45 crore from Rs 1,060.89 crore QoQ.

*ICI Lombard General Insurance Company : The company reported profit at Rs 313.53 crore in Q3FY21 against Rs 294.11 crore in Q3FY20, total income rose to Rs 3,058.91 crore from Rs 2,798.9 crore, premium income increased to Rs 2,611.41 crore from Rs 2,456.16 crore YoY.

*ICI Bank : Mutual funds reduced stake in the bank to 26.35 percent in December quarter from 27.07 percent in September quarter and LIC also lowered stake to 8.4 percent from 8.87 percent, but FPIs increased shareholding to 47.43 percent from 45.66 percent in same periods.

*India will start exporting COVID-19 vaccines from Wednesday, paving the way for many mid- and lower-income countries to get supplies of the easy-to-store Oxford/AstraZeneca drug, of which it said it plans to ship millions of doses within days.

Global Economy

*China's capital Beijing said on Wednesday it will investigate all individuals who entered the city from abroad from Dec. 10 and shut down a subway station after reporting the biggest daily jump in new COVID-19 cases in more than three weeks.
